- A candidate for Bronze is NOT required to have competed any self-trained YEHs at Preliminary and/or 1* but not higher or at Intermediate and/or 2*.
- However, if your Section II list includes 6 YEHs whom you have both trained and competed through Preliminary and/or 1* but not higher OR 6 YEHs you have trained/competed through Intermediate and/or 2*, the word "Silver" or "Gold," respectively, would be printed on your YEH Professional Horse Trainer certificate in addition to the word "Bronze." If your list shows a combination of such horses (competed at both levels, say, 4 through Preliminary and 2 through Intermediate), your certificate would read "Bronze and Silver."
- A candidate receives his/her YEH Professional Horse Trainer certificate after successfully completing an ICP Assessment.
