She also drafts contracts for horse purchases, sales, and leases, assists with negotiating and drafting employment and independent contractor agreements for equine industry workers, and creates equine liability releases for horse owners, trainers, breeders, facilities, veterinarians, transporters and other individuals and entities sponsoring or participating in equine activities. She also has extensive experience developing multi-owner syndicates for horses in numerous disciplines, including eventing, dressage, and jumpers, as well as creating stallion and mare breeding syndicates. The syndicates completed to date range from several owners to multiple owners, range in value from \$5,000 to \$850,000 in value, and vary from very young horses beginning their training to mature horses competing at the highest levels of their sport.
